Product Description

Coats Signal C412 300 is an aramid based fluorescent lime-silver-lime reflective tape for industrial wash heat and flame protective clothing especially firefighter uniforms. Combined with retro reflective and fluorescent elements, it helps to maximise the visibility in nighttime, during daytime or low light conditions.

Product Construction

Coats Signal C412 300 is made of fluorescent lime part and high performance glass beads based silver part laminated on a durable 100% m-aramid fabric backing. The silver part is in the middle of fluorescent lime part.

Areas of Applications

Coats Signal C412 300 is a sewn-on reflective tape for high visibility industrial wash heat and flame protective clothing especially firefighter uniforms where EN 469, EN ISO 11612 and EN ISO 14116 certifications are required. All high visibility flame resistant garments should be made according to proper standards.

Product Certification

Colour and Reflective Performance - EN 20471

Coats Signal C412 300 is approved according to EN 20471 high visibility norm. The fluorescent lime part meets the chromaticity and min. luminance factor requirements. The silver part delivers maximum retro reflective performance. The typical reflective performance (RA in cd/lux/m²) according to EN ISO 20471, table 4 is shown below.

Care Instructions Domestic Wash













Industrial wash

Maximum wash temperature: 75°C

Tumble dry: 90°C

Tunnel dry: 160°C

Use low alkaline surfactant detergent, do not use sodium hydroxide or potassium hydroxide containing detergents, lower pH near to neutral is recommended

Do not use solvenated surfactants

Do not use perborate based bleaching

Soak soap for less than 15 min.

Physical Performance

Coats Signal C412 300 silver part meets or exceeds in origin the performance as per EN ISO 20471, clause 6.1 as well as the requirements in clause 6.2 after exposure to abrasion, flexing, folding at cold temperature, temperature variation, washing, dry cleaning and influence of rainfall.
